



## "Sign up for e-billing?" Contest Rules

### 1. Organizer and contest period

- 1.1. The "Sign up for e-billing" Contest (the "**Contest**") is organized by Énergir, L.P. ("**Énergir**").
- 1.2. The Contest runs in Québec from March 2<sup>nd</sup>, 2021 until 11:59 p.m. to May 15<sup>th</sup>, 2021 (the "**Contest Period**"). All times mentioned in these Contest Rules are Eastern Standard Time. (Canada)

### 2. Eligibility

- 2.1. This Contest is open to all Énergir account holders who are legal residents of Québec and who are aged 18 or over on the Contest enrolment date and who subscribed to electronic billing during the Contest period.

This Contest is not open to employees, representatives and agents of Énergir, its affiliates, advertising and promotion agencies, prize suppliers and all persons with whom any of the foregoing reside.

### 3. How to enter

- 3.1. For the purpose of these Contest Rules, an entrant (the "Entrant") is an account holder who has registered for an electronic billing before 11:59 p.m. on May 15<sup>th</sup>, 2021.
- 3.2. Visit [www.energir.com/cyberaccount](http://www.energir.com/cyberaccount) to register first for a Cyberaccount, then select the "Electronic billing" option, which will automatically be offered during registration. For customers already registered for a Cyberaccount, click the "Bill reception mode" tab in the "Account management" section to sign up for the electronic billing service ("**Entry**").
- 3.3. All Entries must be received by 11:59 p.m. on May 15<sup>th</sup>, 2021.
- 3.4. One (1) Entry per account.
- 3.5. All Entries become the property of Énergir and will not be returned or disclosed for any reason.
- 3.6. No purchase necessary.

### 4. PRIZES

- 4.1 Five (5) prizes, with a total value of \$2,500, will be awarded under the Contest:
  - 4.1.1. Each participants will be winning an amount of \$500 in prepaid credit cards.

### 5. Prize draw and awarding of prizes

- 5.1. Winners will be selected by random draw from all eligible entries received before 11:59 p.m. on May 15<sup>th</sup>, 2021. The draw will be held on May 18<sup>th</sup>, 2020 at around 11:00 a.m., at 1717 rue du Havre, Montréal, Québec H2K 2X3, or another defined location.
- 5.2. If all the contestants meet the conditions in these Contest Rules, the first five (5) participants drawn will be winning each credit cards for a total amount of \$500 by participant.
- 5.3. The odds of winning depend on the total number of eligible Entries received.

5.4. To be declared a winner, selected Entrants must (i) correctly answer, unaided, a time-limited mathematical skill-testing question ( $10+5 \times 8/2$ ) to be administered by telephone or by email, and (ii) provide all the required information (first and last name, e-mail address, telephone number and age).

5.5. Selected Entrants who comply with the Contest Rules:

5.5.1. will be contacted by Énergir by telephone or by e-mail within five (5) business days of the draw; and Énergir will only contact the account holder whose name appears on the billing account.

5.5.2. will have to claim their prizes according to Énergir's instructions, at 1717 rue du Havre, Montréal, Québec, H2K 2X3, within 10 business days of the day they were first contacted. Énergir may, at its discretion, send the prize by mail.

A participant will be disqualified:

- (a) If, after a reasonable attempt, Énergir fails to reach a selected Entrant within the aforementioned time period, for any reason whatsoever; or
- (b) If a selected Entrant does not comply with these Contest Rules,

Énergir will then randomly select further Entrants from the remaining eligible Entries until a winner is declared.

No communications will be made with Entrants except with prize winners.

By participating in this Contest, the winners consent to the use of their name and city of residence on Énergir's website [www.energir.com/contest](http://www.energir.com/contest), without further compensation.

## 6. Release

6.1. Winners will be required to sign a declaration form confirming their eligibility to participate in the Contest, their compliance with the Contest Rules and releasing Énergir, its affiliates, advertising and promotion agencies, prize suppliers, and each of their respective directors, officers, employees, agents, representatives, successors and assigns, from any and all liability arising from losses or damages, of any nature whatsoever, they may suffer or that may arise as a result of participation in this Contest or from the awarding, acceptance or use of the prize and for any damage to the prize during delivery.

6.2. Énergir, its affiliates, advertising and promotion agencies, and each of their respective directors, officers, employees, agents, representatives, successors and assigns, assume no liability arising from (a) a malfunction of any means of communication, or any faulty, incomplete, incomprehensible or erased Entry transmission or (b) by any other reason that may limit any person's ability to submit an Entry and therefore, preventing the person from participating in the Contest.

6.3. Any person participating or attempting to participate in this Contest release Énergir, its affiliates, advertising and promotion agencies, and each of their respective directors, officers, employees, agents, representatives, successors and assigns, from any and all liability for any damages that may arise from participating or attempting to participate in the Contest.

6.4. Subject to approval by the Régie des alcools, des courses et des jeux du Québec (the "Régie"), if required, Énergir reserves the right, at its discretion and without prior notice, to cancel, terminate, modify or suspend the Contest and its Rules, in whole or in part, in the event of human intervention or any other cause, including but not limited to a case of force majeure, that could corrupt or affect the administration, security, impartiality or conduct of the Contest, as provided for in these Rules. In such a case, Énergir shall not be held liable in any manner whatsoever.

6.5. Winners acknowledge that the only guarantee applicable to their prizes which they respectively won under this contest is the manufacturer's guarantee, if such a guarantee is offered.

## 7. Régie des alcools, des courses et des jeux

- 7.1. Any decision by the Contest organizers or their representatives regarding this Contest is final and without appeal, subject to any decision of the Régie with respect to any matter within its jurisdiction.
- 7.2. Any litigation respecting the conduct or organization of a publicity contest may be submitted to the Régie for a ruling. Any litigation respecting the awarding of a prize may be submitted to the Régie only for the purpose of helping the parties reach a settlement.

## 8. General rules

- 8.1. Entries are subject to verification by Énergir. Any Entry that is incomplete, fraudulent or otherwise not in compliance with these Rules will be automatically rejected and will not be eligible for a prize. In such an event, Énergir will make a new random draw in order to award the prizes, as mentioned in the article 5 of these rules.
- 8.2. In no event shall Énergir, its affiliates, advertising and promotion agencies, prize suppliers, and each of their respective directors, officers, employees, agents, representatives, successors and assigns, be required to award more prizes than indicated in these Rules or to award prizes otherwise than in compliance with these Rules.
- 8.3. Prizes must be accepted as described in these Contest Rules and may not be transferred to another person, substituted for another prize, or exchanged for an amount of cash, in whole or in part.
- 8.4. Refusal to accept a prize releases Énergir, its managers, its employees, its representatives, its successors and assigns from all liability or obligation with respect to the winner.
- 8.5. By participating in this Contest, Entrants agree to abide by and be bound by these Rules. Énergir reserves the right to disqualify any person who participates or attempts to participate in this Contest in a manner that is contrary to these Contest Rules or that is unfair to the other Entrants.
- 8.6. The personal information of each participant (name, email address, telephone number and age) provided to enter the Contest will be used solely for the administration of this Contest and for no other reason without the Entrant's consent. By providing this personal information, Entrants consent and agree expressly to its use for the aforementioned purpose.
- 8.7. This Contest is subject all federal, provincial and local laws.
